### **STANDING COMMITTEE REPORTS**

### P-12 EDUCATION COMMITTEE

Your P-12 Education Committee held its scheduled meeting on April 23, 2012. All members were present, except for Chancellor Emeritus Bennett, who was excused.

### **ACTION ITEMS**

### **Charter Schools**

VOTED: That the Board of Regents finds that the proposed revised charter of the Challenge Preparatory Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will permit the charter school to operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the above listed charter revision as proposed by Chancellor of the NYCDOE and the provisional charter is amended accordingly. [P-12 (A) 1]

That the Board of Regents denies the renewal application for the Pinnacle Charter School, that the board of trustees of the Pinnacle Charter School be provided notice of this action and that its charter will terminate upon the expiration of its current charter term on June 30, 2012, and that the board of trustees of the Pinnacle Charter School is directed to take all steps necessary to close the school in accordance with its

charter and the school closure procedures of the Department and cease instruction as of June 30, 2012; including but not limited to the immediate provision of notice of this nonrenewal action to the parents of existing students of the Charter School, the parents of any students in the Charter School's most recent lottery and the parents of students on the Charter School's waiting list, provision for the orderly transfer of student records to the Buffalo City School District and disposition of the Charter School's assets. This action was passed by a vote of 9-1 with Regent Tallon in opposition and Regent Rosa abstaining from the vote. Chancellor Emeritus Bennett was not present at the meeting but wanted to express that his preference would have been for a one-year renewal. [P-12 (A) 2]

Statement from Chancellor Emeritus Robert Bennett regarding the vote taken on the Pinnacle Charter School at the meeting of the Board of Regents on April 24, 2012.

"While I am well aware of the issues presented and the policy implications for keeping Pinnacle opened for an extended term, these issues are far outweighed by what the outcomes will be for these children by placing them back in the Buffalo City School District."

### MATTERS NOT REQUIRING BOARD ACTION

### Dignity Act

The Committee discussed proposed amendments to regulations that would establish standards for a program to train school employees and administrators to promote a positive school environment that is free from discrimination and harassment; and to discourage and respond to incidents of discrimination and/or harassment on school property or at a school function. The proposed rule was discussed by the Committee in February, but has been revised due to public comment. The Committee reached consensus on the intent of the revised proposed rule and will take action at the June 2012 Regents meeting. [P-12 (D) 1]

The Committee discussed proposed amendments to regulations that would establish standards for the reporting of material incidents of discrimination and harassment including, but not limited to, threats, intimidation or abuse based on a person's actual or perceived race, color, weight, national origin, ethnic group, religion, religious practices, disability, sexual orientation, gender or sex. The Committee reached consensus on the intent of the proposed rule and will take action at the June 2012 Regents meeting. [P-12 (D) 2]

<u>Concussion Management Awareness Act</u> – Due to time constraints, this item has been deferred to the June Regents meeting and will be discussed at that time. [P-12 (D) 3]

Proposal to Strengthen the Safety Net for Students with Disabilities – the Committee discussed proposals for strengthening the safety net for students with disabilities to further enable graduation with a local diploma. Discussion focused on feedback from the March 9 stakeholder workgroup meeting and staff recommendations for expanding options for students with disabilities to earn a local diploma beyond the current option of the 55-64 pass score on the five required Regents exams. The Committee endorsed the expanded options and has directed staff to propose regulations as stated in the item. The Committee also directed staff to review current testing accommodation policy for Regents exams to ensure students with disabilities are being provided the maximum appropriate accommodations necessary to demonstrate their performance-based knowledge of the subject areas being tested. [P-12 (D) 4]

<u>Proposal to Create Multiple Pathways to a NYS High School Diploma</u> - The Committee discussed several policy directions that the Board of Regents may wish to consider in establishing specific expanded pathways for high school students to satisfy high school graduation requirements. The Committee discussed the following four recommendations:

- 1. Identifying Global History and Geography as an optional assessment
- 2. Creating two separate courses in Global History and Geography
- 3. Continuing the requirement of the U.S. History and Government Regents exam
- 4. Allowing the use of an approved college and career ready CTE technical assessment in lieu of a required Regents exam, thereby allowing students to follow a CTE pathway to graduation.

The Committee shared concerns about the proposed recommendations, specifically as they relate to the Global exam option. The recommendation to add a CTE assessment as an option for graduation was favorable, but concern was expressed that access to these programs may be difficult for some districts. The Committee agreed with the proposed next steps and felt it is critical to provide an opportunity for public feedback on the proposed recommendations. Additionally, Department staff will begin working with districts to identify existing funding sources that could be leveraged to support the recommendation for a new CTE and STEM pathway program. Further discussion on these recommendations for expanded pathways will continue in June, following the proposed public comment period. [P-12 (D) 5]

### P-12 Education/Adult Career and Continuing Education Services (ACCES)

Your P-12 Education/ACCES Joint Committee held its scheduled meeting on April 23, 2012. All members were present, with the exception of Chancellor Emeritus Bennett, who were excused.

### MATTERS NOT REQUIRING BOARD ACTION

Developing a Framework for Effective Transition from School to Work: A Follow-Up to December 2011 Presentation to the Regents - The Committee was provided an update of the on-going progress being made in the transition from secondary education to employment for youth with disabilities. The Office of Special Education and ACCES-VR are jointly exploring evidence-informed strategies to drive more effective transition outcomes in New York State. A panel presentation was conducted by members of the Freeport Union Free School District and a Senior Vocational Rehabilitation Counselor from the ACCES-VR Garden City District Office. They presented to the Committee their approach on transition practice and the positive outcome that it has. Update on Multiple Pathways to a High School Equivalency Diploma - The Committee was updated on the progress made to draft a Request for Information (RFI) needed to consider multiple pathway options to the New York State High School equivalency diploma. The RFI will help us identify products that are either currently available or may become available which many provide alternative pathways to a High School equivalency diploma. SED has worked closely with both Missouri and Massachusetts to develop a draft RFI which is currently being reviewed internally. SED has involved key researchers and assessment experts in this effort. Consistent with the development of the RFI and Board action in February, we have solidified efforts to engage SUNY and CUNY to determine if their college placement instrument(s) could be used to lead to a High School equivalency diploma. A number of states have expressed concern with the changes to the GED® test and are also planning on issuing Requests for Information and/or Requests for Proposals to explore alternative products or programs. The information contained in New York's draft RFI will be shared across states and used to inform multi-state processes.

### **Higher Education**

Your Higher Education Committee held its scheduled meeting on April 23, 2012. All members were present with the exception of Chancellor Emeritus Bennett.

### Action Items

Proposed Amendment to Subpart 82-1 Relating to Procedures for Hearings on Charges Against Tenured School Employees Pursuant to Section 3020-a of the Education Law. Your Committee voted that Subpart 82-1 of the Regulations of the Commissioner be amended, as submitted, effective April 24, 2012, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the

general welfare in order to implement Education Law section 3020-a, as amended by Chapter 57 of the Laws of 2012. Part B of Chapter 57 of the Laws of 2012 became effective on April 1, 2012. It is anticipated that the rule will be presented for permanent adoption at the June Regents meeting, after the 45-day public comment period required pursuant to the State Administrative Procedure Act.

### MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on April 24, 2012, copies of which have been distributed to each member of the Board of Regents.

Other matters not requiring action:

Teacher and Principal Preparation Program Profiles. The Committee discussed the Department's development of teacher and principal preparation program profiles. The Office of Higher Education is working in collaboration with the Office of P-12 Education, Data Systems Information and Reporting Services on this initiative. The teacher and principal preparation program profiles are one of five data deliverables under the P-20 data system.

Teacher Preparation Support Program. The Committee discussed pursuing with each of the higher education sectors and their respective teacher and school leader preparation programs, opportunities to provide professional development that will ensure a successful transition to the new academic standards in education.

Test Security and Educator Integrity Update. Your Committee received a brief update.

### **Professional Practice**

Your Professional Practice Committee held its scheduled meeting on April 23, 2012. All Committee Members were present, except for Regent Anthony S. Bottar, who was excused. Chancellor Merryl H. Tisch and Regent T. Andrew Brown were also present, but did not vote on any case or action.

### **ACTION ITEMS**

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the

recommendation of the Committee on the Professions, that 23 consent order applications and 4 surrender applications be granted.

These recommendations are made following the review of 31 cases involving eight registered professional nurses, six licensed practical nurses, three dentists, three podiatrists, two certified public accountants, two veterinarians, one licensed practical nurse who is also a registered professional nurse, one pharmacist, one physical therapist, one psychologist, and one registered professional nurse who is also a nurse practitioner.

### Restorations

Your Committee recommends that the application of Jimmy Lee Dutton for the restoration of his license to practice as a licensed practical nurse in New York State be denied. [PPC EXS (A) 4]

Regulations Relating to the Approval of International Medical Schools for Long-Term Clinical Clerkship Placements [PPC (A) 1] – That section 60.10 of the Regulations of the Commissioner of Education be added, as submitted, effective April 24, 2012, as an emergency measure upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare in order to enable the Advisory Committee on Long-Term Clinical Clerkships the opportunity to evaluate pending applications by international medical schools to place students in long-term clinical clerkships in New York State in a timely manner.

Regulations Relating to Occupational Therapy [PPC (A) 2] – That subdivision (b) of section 76.4 of the Regulations of the Commissioner of Education be amended; that section 76.5 be repealed and section 76.7 be renumbered as section 76.5; that section 76.6 be renumbered as section 76.8 and that new sections 76.6, 76.7, and 76.9 be added, all as submitted, effective May 15, 2012, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare in order to ensure that the emergency rule adopted at the February Regents meeting remains continuously in effect until the effective date of proposed regulations to implement Chapter 460 of the Laws of 2011, as published in the March 14, 2012 State Register

Regulations Relating to Occupational Therapy [PPC (A) 2] – In conjunction with the emergency action on occupational therapy regulations referenced in the Approvals section above, the Committee discussed additional regulations needed to implement chapter 460 of the Laws of 2011 with regard to the supervision of holders of limited permits in occupational therapy and the supervision of occupational therapy assistants.

Regulations Relating to Electronic Prescriptions and to Electronic Recordkeeping by Pharmacists [PPC (D) 1] – Discussion of amendments relating to electronic prescriptions and electronically maintained records of pharmacists.

Regulations Relating to the Professional Study, Experience Requirements, and Licensing Examination for Licensure of Landscape Architects [PPC (D) 2] – Discussion of amendments to align the New York State requirements for admission to the Landscape Architect Registration Examination with national standards and to clarify the professional study and experience requirements for landscape architecture candidates.

### Audits/Budget and Finance

The Regents Committee on Audits/Budget and Finance met as scheduled this morning, April 24, 2012. Chair Chapey, Vice Chair Bendit, Chancellor Tisch, Regents Brown, Cottrell, Jackson, Phillips, Tallon, Tilles, and Young were in attendance.

Chair's Remarks: Regent Chapey welcomed everyone and stressed the important role budget, finance, and auditing plays and will continue to play in this challenging economy and through the implementation of the Reform Agenda.

Items for Discussion

Presentation by the New York State School Boards Association (NYSSBA)

The Committee was briefed on the provision of mandatory school board member training. All school board members are required to have six hours in fiscal oversight training as well as training related to the powers, functions, and duties of board of education. In addition to the mandatory training, NYSSBA also provides other training to school board members. NYSSBA represents almost 700 school boards and is also one of the training providers.

### Completed Audits

The Committee was presented with 5 audits this month. One audit was conducted by the Office of Audit Services and 4 by the Office of the State Comptroller. All of the audits were of school districts. One audit examined compliance with the Employment Preparation Education program, the others focused on budgeting, claims process, and a follow-up audit.

### March 2012 Fiscal Report

Our Executive Deputy Commissioner briefed the Committee members. The report provided is for the period ending March 31, 2012, the end of the state fiscal year. The Department will continue to spend funds from that year for a short period of time. The presentation of the 3020a teacher tenure hearing will be modified in future fiscal reports to reflect recently passed legislation.

### **Cultural Education**

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report.

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting

Deputy Commissioner Jeffrey Cannell provided a brief update on the status of the Advisory Council on Museums, reporting on the positive reception he received at a recent meeting of the Museum Association of New York.

CE (A) 1 – Report of the Regents Advisory Council on Libraries – Creating the Future: A 2020 Vision and Plan for Library Service in New York State

The Deputy Commissioner introduced presenters Gerald Nichols, Chair and John Hammond, Vice-Chair of Regents Advisory Council (RAC) on Libraries. The Regents Advisory Council on Libraries, as the oldest continuing Regents advisory body, is responsible to keep the Board of Regents informed about the conditions and needs of the State's libraries, and to suggest policies and actions that would make those libraries more useful for the residents of New York State.

Chairman Nichols began by saying "Two years ago we met with you and asked for your concept of library service in the twenty-first century. Your response was to challenge us to articulate a vision that reflected the needs of our citizens and to develop a strategy to get there. The report before you is the work not only of this Council, but of literally hundreds of library users, supporters and professionals.

But before we talk about this report, let us first acknowledge that we have a problem. Actually, we have many problems.

We know that too many of our children are entering school unprepared to learn.

Too many students are leaving school without the knowledge necessary to survive, let alone thrive, in an information-based economy.

Too many citizens are struggling to retrain, to learn new skills and to find work.

Too many seniors feel out of touch with the world.

And there is too little opportunity for civil discourse about these and the other challenges that we as a society must face together.

Simply put, how do we provide the opportunities and, indeed, empower, all the people of New York to lead a productive and meaningful life.

We, you, have to do better. That is our mission.

We are here today to offer you, as the leaders of the University of the State of New York, an opportunity to fully utilize one of your most valuable assets in order to meet these challenges. Perhaps we have many problems, but with your support, the libraries of our state can offer many solutions. We believe this report offers models of success and a series of practical recommendations to help all our state's libraries to get there.

Regent Dawson moved to accept the report from the Advisory Committee. The motion was seconded by Regent Cea and passed unanimously.

The committee recommended that Deputy Commissioner Cannell and his staff analyze the report and provide an action agenda for the Board of Regents based on the recommendations in the report.

A copy of the Regents Advisory Council recommendations was distributed to committee members prior to the meeting.






