### Teacher and Principal Evaluation Update (as of 9/9/12) Board of Regents

Our Goal – evaluation plans will help principals and teachers improve their practice, and that in turn will help students graduate from high school ready for college and careers.

There is positive momentum! SED, Districts, and Unions have been working very hard. We are cautiously optimistic about the development, submission, review and approval of the remaining APPR plans. The model plans and resources provided by SED are making a difference. There is still a lot of work ahead....

#### Milestones

- A total of 295 plans have been submitted for SED review
- Released 10 "Model" Evaluation Plans on August 22
- SED has provided written and verbal feedback to 151 districts
- There are now 75 districts with approved APPR plans (list is attached)

### **APPR Process and Timing**

- Every plan is subjected to a thorough analysis: two separate reviews + third review to reconcile any differences
- Reviews can take 4 6 weeks
- Resource intensive all areas of SED are assisting additional resources are necessary
- Approved plans are released on a rolling basis
- State Aid Increase Deadline is January 17, 2013 for districts to have approved plans

### Interesting and Innovative Approaches in Model Plans

- Use of additional measures to evaluate educator effectiveness such as student surveys
- Use of between 2 6 formal and informal observations of teaching practice (exceeding required minimum of 2)
- Use of group measures to ensure district-wide commitments to increasing the percentage
  of students proficient in all state assessments, and the expectation that students linked to
  highly effective educators show both growth and high academic achievement
