York: Authorization to Award the Doctor of Physical

Therapy (D.P.T.) Degree

Issue for Consent Agenda

Should the Board of Regents authorize the Board of Trustees of the City University of New York to confer the additional degree of Doctor of Physical Therapy (D.P.T.) at the College of Staten Island of the City University of New York?

Reason(s) for Consideration

Required by State statute.

Proposed Handling

This question will come before the full Board at its September 2012 meeting where it will be voted on and action taken.

Procedural History

At its June 2012 meeting, the City University Board of Trustees adopted a resolution authorizing the College of Staten Island to offer a D.P.T. program in Physical Therapy, to be transferred from the Graduate School and University Center of the City University of New York. The Department received CUNY's request on June 26, 2012.

A related master plan amendment appears on the full Board's September consent agenda.

Background Information

Paragraph (8) of Section 6206 of the Education Law authorizes the CUNY trustees to: "...grant the certificates, diplomas and degrees which were announced in the bulletins of the existing public institutions of higher learning published for the term beginning immediately prior to April sixteenth, nineteen hundred twenty-six, and also such other degrees and honors as the Regents thereafter specifically authorized or may hereafter authorize it to grant."

CUNY has proposed that the College of Staten Island offer the D.P.T program in Physical Therapy that is currently jointly registered with the CUNY Graduate School and University Center of the City University of New York. This independent degree registration will replace the existing Doctor of Physical Therapy program jointly offered by the Graduate School and University Center (the degree-granting institution) and the College of Staten Island.

Degree authorization is necessary as the award represents the College of Staten Island's first use of the Doctor of Physical Therapy degree title. Board of Regents approval of this authorization will allow the registration of acceptable programs leading to the D.P.T. degree.

At College of Staten Island, the Trustees are authorized to award the degrees of Associate in Arts (A.A.), Associate in Science (A.S.), Associate in Applied Science (A.A.S.), Associate in Occupational Studies (A.O.S.), Bachelor of Arts (B.A.), Bachelor of Science (B.S.), Bachelor of Professional Studies (B.P.S.), Master of Arts (M.A.), Master of Science (M.S.), Master of Professional Studies (M.P.S.), and Master of Science in Education (M.S. in Ed.). The College of Staten Island offers programs in the discipline areas of the Biological Sciences, Business, Education, Engineering, the Fine Arts, the Health Professions, the Humanities, the Physical Sciences, and the Social Sciences.

Recommendation

It is recommended that the Board of Regents authorize the CUNY Board of Trustees to award the degree of Doctor of Physical Therapy (D.P.T.) on duly qualified students successfully completing registered D.P.T. programs at the College of Staten Island effective September 11, 2012.

<u>Timetable for Implementation</u>

If the Regents approve the degree authorization, the Department will register the program once the Regents and the Governor approve the master plan amendment authorizing it.
