SUMMARY

Issue for Decision (Consent Agenda)

Should the Board of Regents approve the proposed appointments and reappointments to the State Professional Standards and Practices Board for Teaching?

Reason(s) for Consideration

Required by State regulation.

Proposed Handling

This question will come before the full Board for consideration at its May 2015 meeting, where it will be voted on and action taken.

Procedural History

Terms for members of the State Professional Standards and Practices Board for Teaching are set forth in Regents Rule 3.14. The Board of Regents appoints members to four-year terms, with the exception of the teacher education student member, who is appointed to a two-year term. Board co-chairs are appointed for two-year terms.

There currently are one higher education, three public, and two teacher vacancies on the Standards Board. Additionally, there are five Board members up for reappointment. The individuals below are recommended for appointment to fill these vacancies.

Recommendation

It is recommended that the Board of Regents approve the following appointments to the State Professional Standards and Practices Board for Teaching: Jack Boak (public member), Charles Giglio (teacher member), Yvette Malavé Diaz (public member), and Therese Torchon (teacher member), each for a four-year term beginning July 1, 2015 and ending June 30, 2019; Pilar Sokol (public member) with an unexpired term ending on June 30, 2016; and April Bedford (higher education member) with an unexpired term ending June 30, 2017.

It is recommended that the Board of Regents approve the following reappointments to the State Professional Standards and Practices Board for Teaching: Kathleen DaBoll-Lavoie (higher education member) (co-chair) to complete the term beginning July 1, 2015 and ending June 30, 2019; Margaret Madden (higher education member) to complete the term beginning July 1, 2015 and ending June 30, 2019; Ruth Pagerey (higher education member) to complete the term beginning July 1, 2015 and ending June 30, 2019; Ellen Sullivan (public member) to complete the term beginning July 1, 2015 and ending June 30, 2019; and James Vasquez (teacher member) to complete the term beginning July 1, 2015 and ending June 30, 2019.

Each one of the members seeking reappointment has made valuable contributions to the Board and is eager to continue working with the Regents in this capacity.

A brief biographical sketch of these recommended members seeking appointment and reappointment is included as Attachment A, and a list of the current membership is included at Attachment B.

State Professional Standards and Practices Board for Teaching

Dr. April Whatley Bedford Dean, School of Education CUNY Brooklyn College Brooklyn, New York **Membership Category: Higher Education**

Before her recent arrival to Brooklyn College in July 2014, Dr. Bedford was a full professor in the Department of Curriculum and Instruction in the College of Education and Human Development (COEHD) at the University of New Orleans (UNO) in Louisiana. From 2010 through 2013, Dr. Bedford served as interim dean of the College of Education and Human Development at UNO.

Dr. Bedford received her B.S. Ed. in Curriculum and Instruction, Elementary Education with Reading Specialist certification and a Kindergarten Endorsement from Texas A&M University, and from there she went on to Baylor University, where she received her M.S. Ed. in Curriculum and Instruction with an endorsement in Gifted Education. Dr. Bedford returned to Texas A&M to obtain her Ph.D. in Curriculum and Instruction with a certification in Women's Studies.

An author of over 20 publications and several edited books, Dr. Bedford's scholarly interests include children's literature, teacher education, and literacy development. She has presented at national and international professional conferences and has served as an elected board member of a number of educational associations. Currently, she is a member of the Editorial Review Board of *Urban Education* and the co-editor of the *Journal of Research in Childhood Education*.

While Dr. Bedford served at UNO as interim dean, the university suffered the devastating effects of Hurricane Katrina, including significant infrastructure challenges and near-debilitating budget cuts. With the support and commitment of the COEHD faculty, her college continued to maintain the quality of its programs in spite of the loss of human and financial capital, and maintained its record of NCATE and CACREP accreditation as well as having more nationally recognized programs than any other university in Louisiana.

In July, 2014 Mr. Jack (Jay) Boak retired from the position of District Superintendent of the Jefferson- Lewis- Hamilton- Herkimer- Oneida Board of Cooperative Services following forty four (44) years of service in public education. In his role as District Superintendent and the regional representative of the Commissioner of Education he collaborated with parents, students, teachers, administrators, Boards of Education and business/industry leaders throughout Northern New York to create and enhance educational opportunities in the region.

Mr. Boak began his career in education as a secondary English teacher in the Holland Patent Central School District. Mr. Charles (Charlie) Giglio, the 2015 New York State Teacher of the Year, is the Latin teacher for grades eight through 12 in the Gloversville Enlarged School District. He came out of retirement to join the Gloversville district in January 2006.

Mr. Giglio has permanent New York state certifications in elementary education, secondary English and Latin. He's certified as a school building administrator and school district administrator. He is a past president and vice president of the Learning Disabilities Association of America. He's a member of several professional organizations, including the National Association of State Mental Health Program Directors, Phi Delta Kappa - Professional Fraternity to Education, the National

Association of Pastoral Musicians and the American Guild of Organists. He's a member of the American Classical Association and the Classical Association of New York State. From 1979-81, Mr. Giglio was an adjunct instructor and director of Special Academic Programs (Correctional Education) at Marist College. He taught English at Westfield Junior High School in Westfield, N.J., and was chairman of the English Department. He also taught at Msgr. Farrell High School in Staten Island, N.Y. Dr. Kathleen M. DaBoll-Lavoie Professor Nazareth College Rochester, New York **Membership Category: Higher Education**

Dr. Kathleen DaBoll-Lavoie has served as Professor in the School of Education at Nazareth College for the past five years, and has been teaching at Nazareth since 1991. She has served as the Chair of the Department of Inclusive Childhood Education, overseeing one of the largest undergraduate majors at the institution, seven graduate teacher education programs and one extension program. She was the co-director of the Robert Noyce Scholar Program, funded through the National Science Foundation. She has also served as Associate Chair of the School of Education, the Director of Graduate Inclusive Early Childhood and Childhood Education Programs, and the Director of the Undergraduate Inclusive Childhood/Middle Childhood Education Program. Prior to her tenure at Nazareth, Dr. DaBoll-Lavoie taught at Syracuse University. She began her career in education as a high school social studies teacher at South Jefferson Central School and Lowville Academy.

Dr. DaBoll-Lavoie is Immediate Past President of the New York Association of Colleges for Teacher Education, and serves on the Teacher Education Advisory Group to the New York State Education Department. She is past president of the New York State Association of Teacher Educators, and was a member of the New York State Higher Education Task Force on Quality Inclusive Schooling/ New York State Partnership for Statewide Systems Change 2000. She was also a member of the planning group for "Building a New York State P-16 Educational Quality Information System." She was an invited member of the New York State Teacher Standards Development Working Group, and served on the New York Assessments for Initial Teacher and School Building Leader Certification Work Group. Dr. DaBoll-Lavoie has presented extensively at state and national conferences; her work has focused on the development of inclusive teacher education programs, school/college partnerships, and assessment.

Dr. DaBoll-Lavoie has a B.A. in history, art history and secondary education from the State University of New York College at Potsdam; an M.S.Ed. in secondary education from the State University of New York University Center at Binghamton; and a Ph.D. in Curriculum and Instruction from Syracuse University.

At SUNY Potsdam, she periodically teaches Feminist Research Methods in the Women's and Gender Studies Program and in previous positions taught courses in gender, social, developmental, personality, and research methods in psychology. She was awarded a Sears Foundation Teaching Excellence Award and was voted Faculty Member of the Year at Franklin Pierce College and the Distinguished Teaching Associate Award in the Psychology Department of the University of Massachusetts, Amherst.

Dr. Madden is a former chair of the Board of Educational Affairs of the American Psychological Association former president of the Society for the Psychology of Women (Division 35 of APA). A Fellow of the American Psychological Association, she received the 2008 Sue Rosenberg Zalk Award for Distinguished Service to the Society for the Psychology of Women. She has been a member of the Canton Potsdam Hospital Board of Directors since 2004 and has chaired it since 2011 during a period of rapid growth and transition into a larger health care structure.

Dr. Madden holds a Ph.D. and M.S. in social psychology from the University of Massachusetts at Amherst and a B.A. in psychology from the University of Wisconsin at Madison. She also completed Harvard's Institute for Educational Management in 2012. She is the author of numerous articles, chapters, and presentation on higher education administration, gender and leadership in education, integrating diversity into the psychology curriculum, and attributions for various negative events.

Dr. Ruth L. Pagerey is Assistant Provost for Teacher Education at SUNY System Administration, where she provides leadership for the implementation of a comprehensive agenda of change in teacher and leader education and serves as liaison

between/among teacher and leader education constituencies, including SUNY's campuses offering teacher and leader preparation.

Prior to her position at SUNY System, Dr. Pagerey served as Assistant Dean for Professional Studies in the University at Albany's School of Education, where she led the teacher and leader education program to continuing program accreditation with the Teacher Education Accreditation Council (TEAC). Dr. Pagerey provided oversight of the School's Educational Studies minor, as well as the Pathways Into Education Center, which disseminates information on degree programs, teacher certification, and educational careers. She came to the University from Siena College, where she was Director of Field Experiences and Accreditation. Previously Dr. Pagerey worked in the Office of Higher Education at the State Education Department where she supervised the registration and accreditation of New York State's teacher preparation programs. Dr. Pagerey earned her Ed.D. in Instructional Leadership from St. John's University (Queens, NY) and her M.S. and B. S. in education from the University at Albany.

Ms. Ellen Sullivan works in Research and Education Services for New York State United Teachers. She is working on the American Federation of Teachers i3 grant for teacher evaluation in New York and Rhode Island, and has responsibilities in National Board Certification and early childhood. Previously, Ms. Sullivan was Director for the Greater Capital Region Teacher Center, first joining the teacher center staff in 1996 as a program assistant. The Center encompasses the 93 public school districts, four BOCES and 83 non-public schools in the Capital Region. Prior to this, she was the Education Director for the Junior Museum of Troy, Education Assistant for the Albany Institute of History and Art, and Instructor and Education Assistant at Hudson Valley Community College. She has her B.A. in Education, magna cum laude, from the College of St. Rose, M.S. in Developmental Reading from SUNY Albany and an A.C. in Grant Making and Foundations from New York University and completed the Federal Policy Institute program at Teachers College, Columbia University.

For the last 17 years, Mr. James Vasquez has taught United States History, Participation in Government and Economics at Newcomers High School in Long Island City. Newcomers High School's mission is to provide new immigrant students with an instructional program that emphasizes the development of English language proficiency as well as helping students and their parents with the adaptation process to a new school system, a new city, and a new country.

Mr. Vasquez has embraced the challenge of teaching his academic subject and simultaneously teaching language and literacy skills to students that are primarily English language learners. He works in close collaboration with his colleagues trained in English as a Second Language to develop and adapt curriculum to meet the needs of the schools unique population of students. Since all of the students at Newcomers start as English Language Learners, the school itself has been recognized many times by multiple organizations for its success at easing the acculturation of their students over the years. One year Newcomers ranked #6 in US News & World Report Best High Schools nationwide.
